A. Opening of the sinus (a normal cavity situated above the upper teeth) requiring additional surgery.	
B. Injury to the nerve in the jaw resulting in numbness or tingling of the chin, lip, cheek, gums and/or tongue on the side; this may persist for several days, weeks, months, years, or in remote instances permanently. The need for future microscopic surgery to fix nerves may be necessary.	perated
C. Postoperative discomfort and swelling, that may necessitate several days of home recuperation.	
D. Heavy bleeding that may be prolonged.	
E. Injury to adjacent teeth and fillings.	
F. Postoperative infection requiring additional treatment.	
G. Stretching of the corners of the mouth with resultant cracking and bruising.	
H. Restricted mouth opening for several days or weeks.	
I. Decision to leave a small piece of root in the jaw when its removal would require extensive surgery.	
J. Breakage of the jaw.	
K. If intravenous medication is used, soreness at injection site or along the vein may develop as well as some discolor the injection site.	ation of
L. Cardiac arrest, respiratory arrest, or even death.
